Effective 2018 - 2019

1. This match shall be between the Ohio Valley Athletic Conference (OVAC) and the Mid-Western Athletic Conference (MAC), and will alternate between conference school each year. The 2019 site will be an MAC site (TBA).

2. The date for this year's all-star match shall be **Tuesday, March 12, 2019**, beginning at 7:00PM.

3. The coaching staff shall be composed of the head coach from each classification who won the OVAC Tournament championship that year.
